Subject: Inspection Report Nos. 50-245/82-17; 50-336/82-19

This refers to the routine safety inspection conducted by Messrs. J. Shedlosky and D. Lipinski of this office on August 8 - September 25, 1982 of activities authorized by NRC License Nos. DPR-21 and DPR-65 and to the discussions of our findings held by Mr. Shedlosky with Mr. Mroczka of your staff at the conclusion of the inspection, and to telephone discussions between me and others of the Region I staff with Mr. Opeka and others of your staff on September 14 and 23, 1982.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
