Pursuant to 10 CFR 50.90, Duquesne Light Company requests an amendment to the above licenses in the form of changes to the technical specifications. The proposed changes will incorporate the power operated relief valve requirements in accordance with the guidance in Generic Letter 90-06 and the Improved Standard Technical Specifications with some exceptions to address plant specific design features.

The proposed technical specification changes for Unit No. 1 and Unit No. 2 are presented in Attachments A-1 and A-2, respectively. The safety analysis (including the no significant hazards evaluation) is presented in Attachment B. The typed replacement technical specification pages are presented in Attachments C-1 and C-2.
