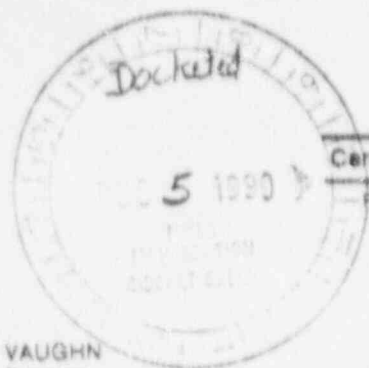
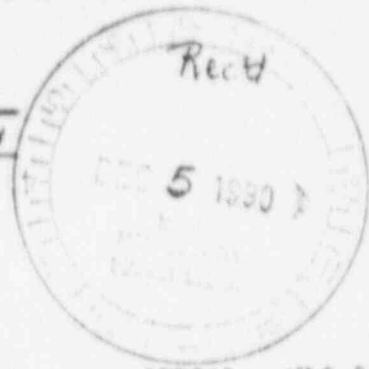

SUBMITTAL OF LICENSE APPLICATION SECURITY INFORMATION FOR BRUNSWICK STEAM  
ELECTRIC PLANT INDEPENDENT SPENT FUEL STORAGE INSTALLATION DOCKET NO. 72-6

Gentlemen:

Carolina Power & Light Company (CP&L) submitted a license application dated April 27, 1989, to construct and operate an Independent Spent Fuel Storage Installation (ISFSI) at our Brunswick Steam Electric Plant (BSEP). In that application, CP&L deferred submittal of the security measures for physical protection.

In accordance with 10CFR72, CP&L hereby submits 15 copies of the proposed annexes to the BSEP Industrial Security Plan. Annex B contains the Security Plan for the BSEP ISFSI; Annex C contains the Safeguards Contingency Plan for the BSEP ISFSI; and Annex D contains the Security Personnel Training & Qualification Plan for the BSEP ISFSI.

Portions of the attachment have been designated as Safeguards Information and should be protected in accordance with the provisions of 10CFR73.21. It is requested that those parts of the attachment which are not protected in accordance with 10CFR73.21 be withheld from public disclosure in accordance with 10CFR2.790(d)(1).
