This refers to the routine safety inspection conducted by C. Rowe of this office on August 16 - 20, 1982, at Salem Nuclear Generating Station, Hancocks Bridge, New Jersey, of activities authorized by NRC License Nos. DPR-70 and DPR-75 and to the discussions of our findings held by C. Rowe with Mr. J. Driscoll and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Our inspector also verified the steps you have taken to correct the violation brought to your attention in the enclosure to our letter dated May 28, 1982. We have no further questions regarding your action at this time.

Within the scope of this inspection, no violations were observed.

No reply to this letter is required. Your cooperation with us in this matter is appreciated.




