SUBJECT: OFFICE CONCURRENCE ON RULEMAKING ACTIONS INVOLVING ANNUAL
PHYSICAL FITNESS PERFORMANCE TESTING AND UPDATED FIREARMS
QUALIFICATIONS

The Office of Administration concurs, subject to the comments provided, on the rulemaking package that would amend regulations contained in 10 CFR Part 73. The rulemaking package contains a proposed rule that would impose on security forces at Category I licensees either annual physical fitness performance testing and training programs or a quarterly, site-specific, content-based physical fitness performance test developed by the licensee. The package also contains a final rule that would require a revised day firearms qualification course for Tactical Response Team members, armed response personnel, and guards at Category I licensees. We have attached a marked copy of both the proposed and final rule package that presents our comments.

When the documents are forwarded for signature and publication, please have a member of your staff include a 3.5-inch diskette that contains a copy of each document in WordPerfect 5.0 or 5.1 as part of the transmittal package. The diskette will be forwarded to the Office of the Federal Register and the Government Printing Office for their use in typesetting the documents.

We have informed the Information and Records Management Branch, IRM, that we are reviewing this rulemaking action and will continue to coordinate our efforts by providing IRM with a copy of our response. We have also asked IRM to provide ADM with a copy of its response.

To assist in the preparation of the list of documents centrally relevant to this rulemaking action that is required by NRC's regulatory history procedures, the designator "AD30-1" should be placed in the upper right-hand corner of each document pertaining to the proposed rule and the designator "AD30-2" should be placed in the upper right-hand corner of each document pertaining to the final rule that is forwarded to the Nuclear Documents System (NUDOCS).


