SUBJECT: NRC INSPECTION REPORT 030-30996/94-01

This refers to the routine, unannounced inspection conducted by Mr. Richard A. Leonardi, Jr., of this office on March 28-29, 1994. The inspection included a review of activities authorized by Byproduct Material License 15-26978-01. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of the activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, and observation of activities in progress.

No violations or deviations were identified; therefore, no response to this letter is required.

The inspector determined that the licensee had relocated its facilities in December 1993 from DeSoto, Kansas to Lenexa, Kansas. The NRC was notified of the relocation in a timely manner. The inspector noted that the licensee has performed 50 percent of its work in the state of Missouri using four mobile radiography units and two full-time radiographers. A review of randomly selected records indicated that the Radiation Safety Officer appeared effective in maintaining an appropriate leve: f program oversight and had effectively implemented adequate control over licensed activities.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
