In accordance with 10CFR50.90, South Carolina Electric & Gas Company (SCE&G) is submitting an amendment request to License NPF-12 to change the Technical Specifications (TS) for the Virgil C. Summer Nuclear Station (VCSNS). The proposed change is a revision to TS 6.4, "Training." The purpose of this change is to incorporate the requirements of the revised regulation Title 10, CFR, Parts 55.31(a)(4) and 55.59(c), in that VCSNS Training and Requalification Programs are accredited and based on the systems approach to training as defined in 10CFR55.4.

The proposed TS change is identified in Enclosure 1. The safety evaluation is provided in Enclosure 2. A proposed no significant hazards evaluation performed pursuant to 10CFR50.92 is provided in Enclosure 3.

The proposed TS change has been reviewed and approved by the Plant Safety Review Committee and the Nuclear Safety Review Committee.
