SUBJECT: WITHHOLDING PROPRIETARY INFORMATION FROM PUBLIC DISCLOSURE-
CALCULATION CNC-1227.00-00-0051 FOR CATAWBA NUCLEAR STATION,
UNITS 1 AND 2

Your letter of April 29, 1993, submitted a Duke Power Company (DPC) calculation "Offsite Dose from a Postulated Main Steam Line Break," CNC-1227.00-00-0051, Revision 1. This calculation provided main steam line break leakage calculations in support of the staff's review of the application of steam generator tube interim plugging criteria (IPC) for Catawba Unit 1, Cycle 7. The calculation was not designated to be proprietary and, accordingly, has been placed in the public document room.

Your letters of October 5 and December 14, 1993, submitted Revisions 2 and 3 to calculation CNC-1227.00-00-0051. Revision 3 supercedes, in its entirety, the earlier revisions. Your affidavit dated December 14, 1993, submitted with Revision 3, requested that the report be considered proprietary in its entirety. We have identified numerous concerns with this request as follows:

- (1) A proprietary and a non-proprietary version of the report should be submitted. The staff considers it very unlikely that the entirety of this calculation meets the criteria for proprietary information.
- (2) The staff notes that much of the information in Revision 1 is repeated in Revision 3. As noted above, that information is already in the public domain and is, thus, ineligible for proprietary classification in Revision 3.
- (3) The staff notes that your affidavit refers to technical information owned by EPRI and by Combustion Engineering, Inc. Consistent with the requirements of 10 CFR 2.790, an affidavit must be submitted by the owners of all of the information in the submittal. The information owned by each entity should be so designated. The technique for doing this is utilized in numerous documents developed by Westinghouse Electric Corporation. For example, in the WCAP-13715/WCAP-13716 that was submitted with the DPC letter of April 29, 1993, has been found to be appropriate in this regard.


