The purpose of this modification is to provide FY 1994 for incremental funding in the amount of \$92,422.00. Accordingly, the contract is modified as follows:

Under Section B.3., CONSIDERATION AND OBLIGATION--COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991) paragraph c. is deleted and the following is substituted in lieu thereof:

"c. The amount currently obligated by the Government with respect to this contract is \$172,422, of which the sum of \$157,320 represents the estimated reimbursable costs, and of which \$15,102 represents the fixed fee."

A summary of obligations for this contract from award date through the date of this action is given below:

Total FY 93 obligations: \$80,000.00 Total FY 94 obligations: \$92,422.00

Cumulative Total of NRC Obligations: \$172,422.00.

This modification obligates additional FY94 funds in the amount of \$92,422.00.

All other terms and conditions of the contract remain unchanged.
