This letter supplements Callaway's Generic Letter 89-10 Close-Out submittal ULNRC-02964 to clarify our position by adding commitments as agreed during the conversation on April 19, 1994 with NRR and Region III.

Through a revision to our MOV program description, EDP-ZZ-01114, Callaway will continue to actively pursue additional valve specific data for those MOVs listed below in order to demonstrate the conservatism in the assumptions documented in Request For Resolution 8746, Revision I.

This data will be pursued through the EPRI MOV Predictive Performance Program, the Midwest Engineering Managers Conference and other utility differential pressure (DP) test data. The results of this effort will be documented in an on-site engineering evaluation when complete.
