

The purpose of this modification is to provide incremental funding in the amount of \$40,000.00 for the lease and maintenance of telecommunication equipment at Region V. Accordingly, the contract is hereby modified as follows:

Under Section B.2, Consideration and Obligation, delete the amount of "\$7,035,618.96" in paragraph b. and insert the amount of "\$7,075,618.96". In addition, delete paragraph c. in its entirety and substitute the following paragraph in lieu thereof:

"c. The total obligated amount for each NRC location is as follows:
