The purpose of this modification is to provide incremental funding in the amount of \$25,000.00. Accordingly, the contract is modified as follows:

1. Section B.2, "Consideration and Obligation-Cost Reimbursement (June 1988) Alternate I (June 1988)", paragraph "b" is revised to read as follows:

"b. The amount presently obligated by the Government with respect to this contract is \$364,000.00."

All other terms and conditions, including the contract ceiling of \$1,308,203.00, shall remain the same.
