## Subject: BWROG MODEL CONTAINMENT INSPECTION PROGRAM

The BWR Owners' Group (BWROG) appreciates the opportunity to provide to you the attached Model Containment Inspection Program (CIP). The attached is provided for NRC consideration in response to your request for such information following submittal in February 1993 of our comments on the proposed generic communication (reference 57 Federal Register 54860, dated November 20, 1992). This topic was most recently discussed at the September 28, 1993, NRC/BWROG Management Meeting, at which you requested receipt of this information by November 1993.

As you know, at the NRC's initiative the BWROG and NRC have established a beneficial dialogue on this topic dating back to 1989. The BWROG shares the NRC's interest in maintaining containment integrity considering the importance of the containment to public health and safety. The BWROG goal, reflected in the attached CIP, is to establish an approach which is technically sound and cost-beneficial, and which recognizes plant-specific differences in containment design, circumstances, and actions already taken. It is the position of the BWROG that implementation of the CIP will assure identification for appropriate resolution of potential containment shell degradation well before it affects containment integrity.

The BWROG CIP addresses all of the containment integrity issues and is the preferred accornative to both the inspection requirements proposed by the NRC in 57 Federal Register 54860 and the requirements contained in Section XI, Subsection IWE of the ASME Code. The CIP is a stand-alone document which represents the current BWROG position and supplants our earlier communications on this topic.

The BWROG and its member utilities have devoted a significant amount of time and energy to the development of the Model CIP. The Model CIP has undergone an extensive review by the BWROG Containment Inspection Committee.
