RE: Annual Fees for License #13-26020-01

I intend to request an exemption from our annual fee of \$14,320.00 (\$13,100 + \$1,220.00 surcharge, current category 3L, previous category exempt) for radioisotope usage in the Biology and Geology departments of Depauw University. The reasons for our exemption request will be described in detail in a forthcoming letter, to be delivered before the deadline of Nov. 17th, 1993. We are now waiting for the Commission-approved guidelines, to be announced shortly in the Federal Register, before proceeding with our exemption request.

It is my understanding from the Aug. 6th, 1993 NRC notice to Non-profit educational institutions that any licensee seeking an exemption to the new annual fees will not be required to pay the assessed fee by the Aug. 19th deadline. Payment or termination of license will be required 30 days after the Commission's decision on the exemption request. If I am incorrect in this interpretation of your notice, please inform me as soon as possible so that we remain compliant with NRC regulations.
