Subject: Systematic Assessment of Licensee Performance (SALP) and your letter, PLA-1150, July 2, 1982

This refers to the SALP for Susquehanna Steam Electric Station conducted by this office on June 1, 1982, and discussed with you and your staff at the subject meeting on June 17, 1982. The list of attendees is attached as Enclosure 1. The NRC Region I SALP Report is attached as Enclosure 2 and covers the period March 1, 1981 to February 28, 1982. Your letter, dated July 2, 1982, which we requested in our letter of June 4, 1982, provided commitments for performance improvements. These letters are attached as Enclosures 3 and 4.

Overall, we find that your performance of construction and preoperational activities is acceptable and directed toward safe facility completion. We found your management attention and involvement to be aggressive and oriented toward nuclear safety; effective use of ample resources has resulted in a high level of performance.

In our meeting of June 17, we discussed our assessment of your regulatory performance, your comments on the SALP Program and assessment, and the actions the you are taking to improve you performance. We have also reviewed your letter of July 2, and determined that your actions to improve performance in the areas needing attention are responsive to those specific areas. We will give these areas careful review.

We consider that our meeting was beneficial and improved mutual understanding of your activities and our regulatory program. Based on your comments during our meeting and your July 2 letter, we have found that no changes to our assessment are necessary; and, therefore, we have not supplemented our report.

In accordance with 10 CFR 2.790(a), a copy of this letter and its enclosures will be placed in the NRC Public Socument Room. No reply to this letter is required. Your actions in response to the NRC Systematic Assessment of Licensee Performance will be reviewed during future inspections of your licensed activities.
