The purpose of this modification is to provide incremental funding in the amount of \$4,000.00 which increases the obligated amount from \$36,000.00 to \$40,000.00. Accordingly, the contract is hereby modified as follows:

Under Section B.2, Consideration and Obligation, the first sentence of paragraph b. is deleted in its entirety and the following sentence is substituted in lieu thereof:

"b. The amount presently obligated with respect to this contract is \$47,760.00."
