SUBJECT: FITNESS FOR DUTY CONCERNS AT ZION

Thank you for your letter dated April 15, 1994, in response to our March 14, 1994 letter regarding Fitness for Duty (FFD) concerns at Zion Station.

In our letter we requested that you verify (a) that the named individuals have met the requirements under your FFD policy and procedures; (b) that the named individuals were administered FFD tests and have been subject to a random drug and alcohol testing program; and (c) that the FFD tests were determined to be negative by the Medical Review Officer. Additionally we asked that you review the access authorization and FFD records to determine any drug/alcohol history and that you interview individuals' supervisors to determine any behavioral observation concerns.

Your response indicated that the individuals were granted unescorted access after meeting the requirements of your FFD and access authorization programs and have been subject to the random testing program. Random tests were conducted on one of the two subjects with negative results. Although subject to the random testing program since being granted unescorted access, no random tests have been conducted on the second individual.

Your response also indicated that suitable inquiry and access authorization records checks revealed no previous drug/alcohol histories or other deleterious criminal history/background information for either individual. Both individuals had good attendance records and both work history and work quality were considered good.

Your conclusion that the concern was not credible appeared supported based on the limited information provided regarding this concern and the results of your investigation. We request that you retain the supporting documentation of your investigation of this concern for a minimum of one year from the date of this letter.
