The medical director meeting related matters have been produced to the IIT Team and to OI. Those provided to the IIT Team at the time of the accident were our <u>originals</u> and copies were not maintained. Therefore, I would suggest you review those materials carefully. They are in the possession of the NRC.

With respect to those documents produced later to OI, I direct your attention to E000715, E000874, E000875, S-1249, M000860, M000861, M000862, M000863, M000864, M000865, M000652, H000653, E000090, E000091, E000092. None of these documents were redacted. If you have any future questions regarding this matter, please let me know.

On March 28, 1994 I notified Mr. Kenna that I have made arrangements for him to go to each of the 6 centers and review any personnel-type files that exist there. To date, I have not heard from him. I want to get that accomplished as soon as possible.

Finally, I include herewith a letter from the Assistanc U.S. Attorney for the Western District of Pennsylvania indicating that the referral made by the NRC regarding the Indiana incident has been declined. According to the NRC, all three referrals that were made by them have been completely declined by both the appropriate attorneys in the Middle District and the Western
