Gentlemen:


As provided in 10 CFR 171.11, Davis & Elkins College respectfully requests exemption from the fee associated with license #SNM-1987.

Davis & Elkins College holds in storage a tiny unit of plutonium, 32 grams (2 Curies), which is pending transfer to the US Department of Energy for disposal. The college does not utilize this isotope and has been awaiting instructions for its transfer.

Davis & Elkins College is a small private institution with very limited fiscal resources. We believe that the fee \$3,120 listed on invoice #AM00349-93 dated 08/21/1993 was incorrect and should not exceed \$1,800 in any case.

We request exemption from this entire fee in order that these funds may be used to transfer the isotope to the US Department of Energy.
