SUBJECT: VOGTLE ELECTRIC GENERATING PLANT (VEGP) SAFEGUARDS CONTROL  
PROGRAM CORRECTIVE ACTIONS

During the Enforcement Conference at the Region II Office on November 13, 1990, concerning the repetitive instances of safeguards material control violations, you committed to provide the NRC with a detailed specification of the corrective action program which Georgia Power Company (GPC) would implement to prevent future occurrences of this problem. The specific method by which this information would be provided was to be communicated to you after Regional management review.

In order to ensure that an effective, yet timely, resolution to this matter is effected, it is necessary that your response be received in Region II by November 26, 1990. It should include a detailed description of the corrective actions which you plan to implement and the milestone dates associated with each action.
