Dear Mr. Hirsch:

This is in partial response to a letter dated August 10, 1982, from Dorothy Thompson, in which she requested, pursuant to the Freedom of Information Act (FOIA), documents relating to the UCLA Lab and research reactors. In a telephone conversation between you and Nina Toms of my staff, you requested our responses to be forwarded to you rather than to Ms. Thompson.

As explained to you by Ms. Toms, it is NRC's policy to waive 75 percent of the costs for documents relating to contentions admitted by an Atomic Safety and Licensing Board. Therefore, the charges for searching and reproducing the documents for this request will be assessed at 25 percent of actual costs. You will subsequently be billed by our Division of Accounting for the enclosed documents.

In a telephone conversation between Mr. John C. Carr and you on September 2, 1982, Mr. Carr informed you that certain documents relating to the FOIA request need further coordination between our office and the Region V Office in California to identify and remove safeguards information covered by Section 147 of the Atomic Energy Act and Exemption (3) of the Freedom of Information Act. We expect to be able to complete our response by September 17, 1982. Appendix A is a partial list of documents which are relevant to your request.
