Dear Congressman McMillen:

I am responding to your October 11, 1990, letter which requests our comments on the concerns expressed by your constituent, Mr. Thomas W. Henke regarding payments he considers due his firm, Business Computer Interface, Inc. (BCI).

BCI was a subcontractor under our contract with Technassociates, Inc. (TI) which expired on June 15, 1989. During our analysis of TI's invoices in January 1988, we found a discrepancy between the hours billed and our knowledge of the time worked by Mr. Henke. By letter dated April 5, 1988, we notified TI of this discrepancy and suspended payment of the costs in question. Upon further review, we referred this matter to the Inspector General on August 22, 1988, where it is the subject of an ongoing investigation. Once this investigation is completed, we will promptly notify Mr. Henke and take the appropriate action with respect to the questioned costs.
