This refers to the routine inspection conducted by Mr. J. M. Dunlap of this office on July 12-15, 1982 at Berwick, Pennsylvania of activities authorized by NRC License No. CPPR-101 and to the discussions of our findings held by Mr. Dunlap with Mr. H. W. Keiser of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 73.21 of the NRC's regulations, documentation of security measures for the physical protection of special nuclear materials and certain plant equipment vital to the safety of production or utilization facilities is deemed to be Safeguards Information. Each person who produces, receives or acquires Safeguards Information is required to ensure that it is protected against unauthorized disclosure. Therefore, except for the report cover sheet, the enclosures to this letter and your response to this letter will not be placed in the Public Document Room and will receive limited distribution pursuant to 10 CFR 73.21(c).
