The purpose of this letter is to request a change to License Condition 2.D. This License Condition should be revised as follows.

.....Change J dated April 1, 1982, Change K dated May 4, 1982, Change L dated July 9, 1982, Change M dated October 15, 1982, and including Chapter 11 revision dated June 5, 1981; and "Susquehanna Steam Electric Station Security Training and Qualification Plan" dated May 27, 1980 with Revision 1 dated April 30, 1981, and Change A dated August 26, 1981.

Change M to the Physical Security Plan was provided in PLA-1355 dated October 25, 1982. Change A to the Security Training and Qualification Plan was provided in PLA-921 dated September 1, 1981.

The proposed change has been determined to be Class II in nature and the appropriate fee is enclosed.




