On March 29, 1994, the Deputy Executive Director for Nuclear Reactor Regulation, Regional Operations, and Research issued IA 94-003 to Mr. Dailey, entitled "Robert C. Dailey; Order Prohibiting Involvement in Certain NRC-Licensed or Regulated Activities (Effective Immediately)." 59 Fed. Reg. 14688, March 29, 1994. The Order prohibits Mr. Dailey from participation in any respect in any NRC-licensed activities.


