We request that you consider this letter our formal response to your notice of violation dated March 31, 1994.

Regarding your notice of violation:

ITEM 1: "...as of March 14, 1994, the licensee routinely transported licensed material under the general license pursuant to 10 CFR 71.12 and the licensee had not submitted in writing to NRC prior to the first use of the transport package the licensee's name, license number, and the package identification number."

Oversight. Until brought to our attention during the NRC inspection of March 14, 1994, responsible personnel were not specifically aware of this requirement. Neither our operating and Emergency Procedures, or our 10CFR71 Quality Control Program provide specific mention of this submittal to the NRC.

CORRECTIVE STEPS TAKEN AND RESULTS ACHIEVED:

A review of files containing the package certificates was conducted, and on 24 March 1994, a letter was sent to the Office of Nuclear Materials Safety and Safeguards requesting authorization to use packages for which we had evidence of proper certification. Response from the NRC authorizing use was received on 04/22/94. A copy of the correspondence is attached.

A review of shipping documents for the 1993 and 1994 calendar years was also conducted. It was determined that proper certification did not exist for one shipping container. On 8 April 1994, copies of certificates for this package were received. Another letter, dated 8 April 1994, was written to the Office of Nuclear Materials Safety and Safeguards requesting authorization to use that package. A copy of the correspondence is attached.

CORRECTIVE STEPS THAT WILL BE TAKEN TO PREVENT FURTHER VIOLATIONS:

The Quality Program Manual (10CFR71) shall be revised to include clear discussion that packages, as well as exposure devices require evidence of certification prior to first use. A section regarding the procurement of source material shall be included, with procurement instructions to state that certificates of packages and exposure devices must be obtained and in-hand before first use. A documented training session shall be conducted to inform all radiographers of this requirement.

THE DATE WHEN FULL COMPLIANCE WILL BE ACHIEVED: 31 May 1994

ITEM 2: "... as of March 14, 1994, the licensee transported outside the confines of its plant packages of radioactive materials without ensuring by examination or appropriate test that external radiation levels were within allowable limits."

REPLY:

REASON FOR THE VIOLATION:

Misinterpretation of 10CFR71.4 "Packaging" definition. Our operating and emergency procedures have never (29 June 1987 to the present), specified the proper monitoring criteria for exclusive use shipments. Our Daily Utilization Log, which contains instructions for recording monitoring results, has always stated, "Reading at driver's seat," and "Reading at external surface of vehicle/trailer."

CORRECTIVE STEPS TAKEN AND THE RESULTS ACHIEVED:

The daily utilization log has been revised to indicate the additional monitoring requirement, "Reading at external surface of outer container." This revised form is presently being used.

CORRECTIVE STEPS THAT WILL BE TAKEN TO PREVENT FURTHER VIOLATIONS:

Our operating and emergency procedures shall be revised to include the proper monitoring criteria for exclusive use shipments. A documented training session shall be conducted to inform all radiographers of this requirement.


