## Gentlemen:

Enclosed is the <u>Dresden Nuclear Power Station Monthly Operating</u> <u>Summary Report</u> for April 1994. In the report for March 1994 (Reference 4), it was noted that a Problem Investigation Form (PIF) was issued to resolve discrepancies identified by the Idaho Lacional Engineering Laboratory (INEL) in the Dresden data (Reference 1). Corrected totals were provided for cumulative gross thermal, gross electric and net electric generation for Unit 2, and cumulative gross electric and net electric generation for Unit 3. The report for April 1994 corrects errors identified in the reactor criticality hours and generator on-line hours for Unit 2, as footnoted in Section 3.1 of the report. Additional errors identified in the Unit 2 gross thermal and electric cumulative totals provided in the March 1994 report (Reference 4) have also been corrected and are footnoted in Section 3.1.
