SUBJECT: FORMAL SUBMITTAL ON RADIOLOGICAL EFFLUENT TECHNICAL SPECIFICATIONS (RETS) AND OFFSITE DOSE CALCULATION MANUAL (ODCM)

On September 24 and 25, 1981, we met with your staff to discuss your RETS and ODCM proposals for Beaver Valley 1. Many issues were resolved at that meeting and during subsequent discussions between NRC, Franklin Research Center (FRC), and DLC. On May 6, 1982, we initiated a conference call between representatives of the DLC, NRC, and FRC. At the conclusion of that conference call, all items regarded as deviations from the NRC requirements were resolved. Since May 6, 1982, a final draft copy of the RETS prepared by DLC has been reviewed by FRC and found to meet the intent of NRC requirements. All that remains is for you to make your formal submittal.

In the past several weeks there have been a number of phone calls but no formal request has been made by NRC regarding the final submission to be made by a certain date. Mr. K. Grada of your staff recently indicated to the NRC project manager, Mr.P. Tam, that the formal submittal will be made near the middle of September. Since we have as yet received no such submittal and would like to close this item out as expeditiously as possible, please provide us a schedule for submittal which is commensurate with the other regulatory demands on your resources and represents a justifiable position in your priorities.
