Subject: Systematic Assessment of Licensee Performance (SALP)

This refers to the July 12, 1982 Peach Bottom Atomic Power Station SALP discussed with you and your staff on July 27, 1982. The list of attendees is attached as Enclosure 1. The SALP Report, attached as Enclosure 2, covers the period July 1, 1981 through June 30, 1982 and includes NRC observations on your activities through July 1982. Your August 16, 1982 letter, which was requested in our July 15, 1982 letter, provided commitments for performance improvements. Those letters are attached as Enclosures 3 and 4.

Overall, we find that your performance of licensed activities is acceptable and directed toward safe facility operation. For Licensing activities, we found your management attention and involvement aggressive and oriented toward nuclear safety; effective use of ample resources has resulted in a high level of performance. However, your performance in the areas of Radiological Controls, Fire Protection and Housekeeping was found to be in need of increased NRC and Philadelphia Electric Company management attention.

In our July 27, 1982 meeting, we discussed our assessment of your regulatory performance, your comments on the SALP program and assessment, and the actions you are taking to improve performance. We have also reviewed your August 16, 1982 letter and determined that your actions to improve performance in areas needing attention are generally responsive. We will be reviewing the details and results of your efforts to improve radiation protection, and fire protection and housekeeping. Regarding the SALP comment relative to annunciator failures, it was intended to recognize the more conservative approach adopted by PECO and should be viewed as a positive aspect of your operations.

We consider that our meeting was beneficial and improved mutual understanding of your activities and our regulatory program. Based on your comments during our meeting and your August 10, 1982 letter, we found that no changes to our assessment are necessary and did not supplement our report. We have, however, made minor editorial and typographical corrections that did not affect our assessment or conclusions.

In accordance with 10 CFR 2.790(a), a copy of this letter and its enclosures will be placed in the NRC Public Document Room. No reply to this letter is required.
