The purpose of this modification is to: (1) exercise the 1 year option in accordance with contract clause 1.14, FAR 52.217-9, "Option to Extend the Term of the Contract--Services (APR 1984)," and (2) increase the contract ceiling and obligated amounts by \$28,479.00 from \$27,696.61 to \$56,175.61. Accordingly, the contract is hereby modified as follows:

1. Under Section B.4, Consideration and Obligation--Delivery Orders (JUNE 1988), the first sentence of paragraphs a. and b. are deleted in their entirety and the following is substituted in lieu thereof:
 - a. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered and accepted under this contract is \$56,175.61.
 - b. The amount presently obligated with respect to this contract is \$56,175.61."
2. Under Section F.2, Duration of Contract Period (MAR 1987) Alternate IV (JUNE 1988), the paragraph is revised to read as follows:

"The ordering period for this contract shall commence on December 15, 1989 and will expire on December 14, 1991. Any order issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.)"
3. Wage Determination No. 86-1259 (Rev. 6) dated August 8, 1989, which was the applicable wage during the time of award remains as the current applicable wage determination for the option period.

All other terms and conditions of the subject contract remain unchanged.
