14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to incorporate into Section B of the contract, the estimated cost for the three one-month options identified in Section G.5 of the contract. The negotiated costs for these options were reflected in the Contractor's best and final proposal dated September 12, 1990, which was accepted and incorporated by reference in the contract; however, these costs were inadvertently omitted in Section B of the contract. This modification corrects this administrative error and exercises Options One and Two of the contract and therefore extends the expiration date of the contract. Accordingly, the following changes are hereby made:

Except as provided herein, all terms and conditions of the document referenced in item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.

1. Under Section B.3, "CONSIDERATION AND OBLIGATION--COST PLUS FIXED FEE", the following new paragraph "d." is added and made a part of this contract:

"d. As discussed under Section G.5 - "OPTION TO EXTEND SERVICES", there are three one-month options to require the Contractor to perform the efforts described in Section C - Description/Specification/Work Statement. The total estimated cost to the Government for full performance of any of the three options within this contract is \$52,011 each, of which the sum of \$47,936 represents the estimated reimbursable costs, and of which \$4,075 represents the fixed fee."

2. The Government hereby exercises Option One and Option Two under this contract, by this modification. Therefore, Under Section B.3, "CONSIDERATION AND OBLIGATION--COST PLUS FIXED FEE", paragraphs "a" and "c" are deleted in their entirety and the following new paragraphs "a" and "c" are substituted in lieu thereof:

"a. The total estimated cost to the Government for full performance of this contract is \$273,198, of which the sum of \$251,795 represents the estimated reimbursable costs, and of which \$21,403 represents the fixed fee."

"c. The amount presently obligated by the Government with respect to this contract is \$273,198."

3. The expiration date as set forth in Section F.6 - Duration of Contract Period is extended by two months from December 23, 1990 to February 23, 1991.
4. Section C - Description/Specification/Work Statement, as well as all other terms and conditions under the contract shall remain the same.
