
Subject: Seabrook Station 1990 Biennial Exercise Scenario

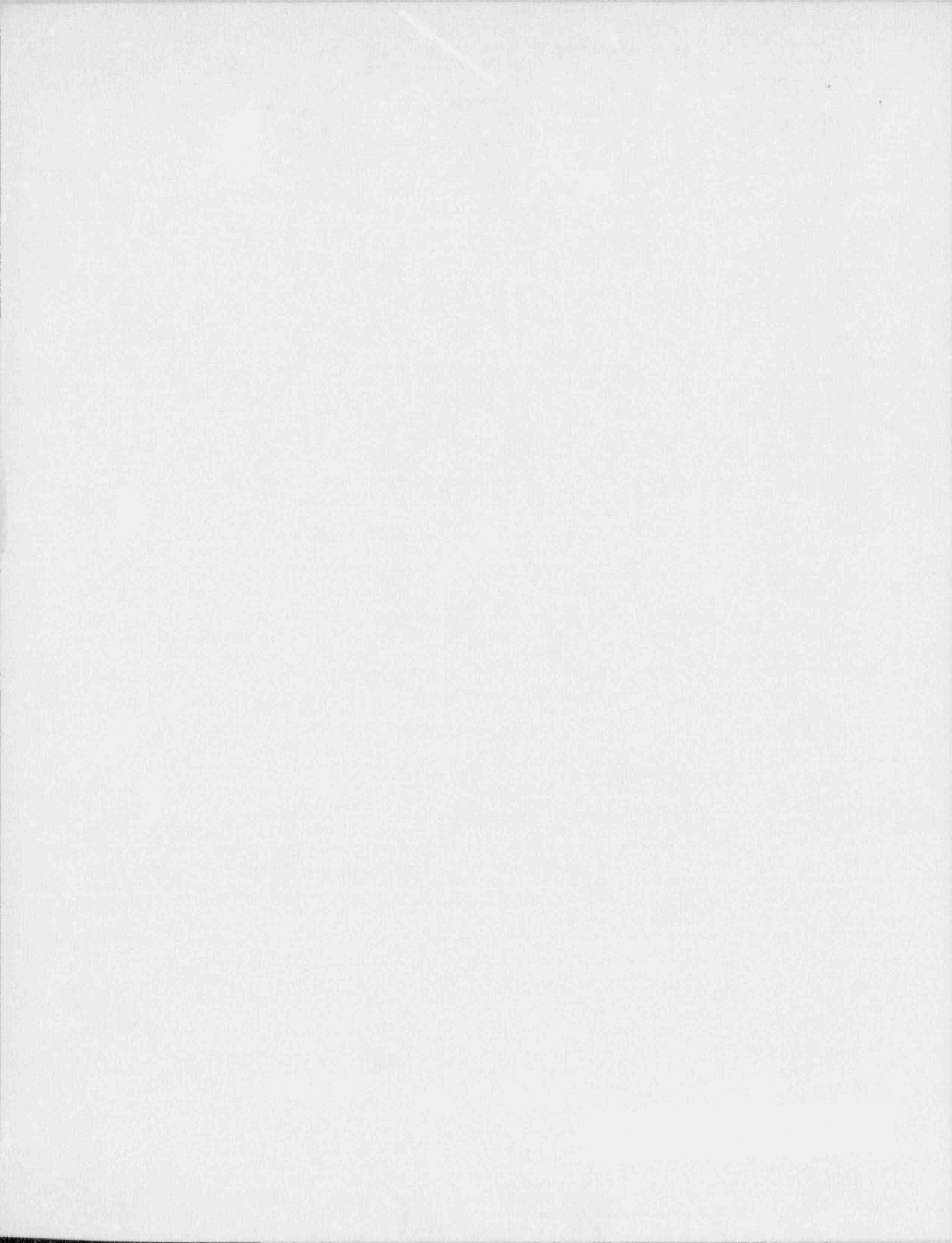

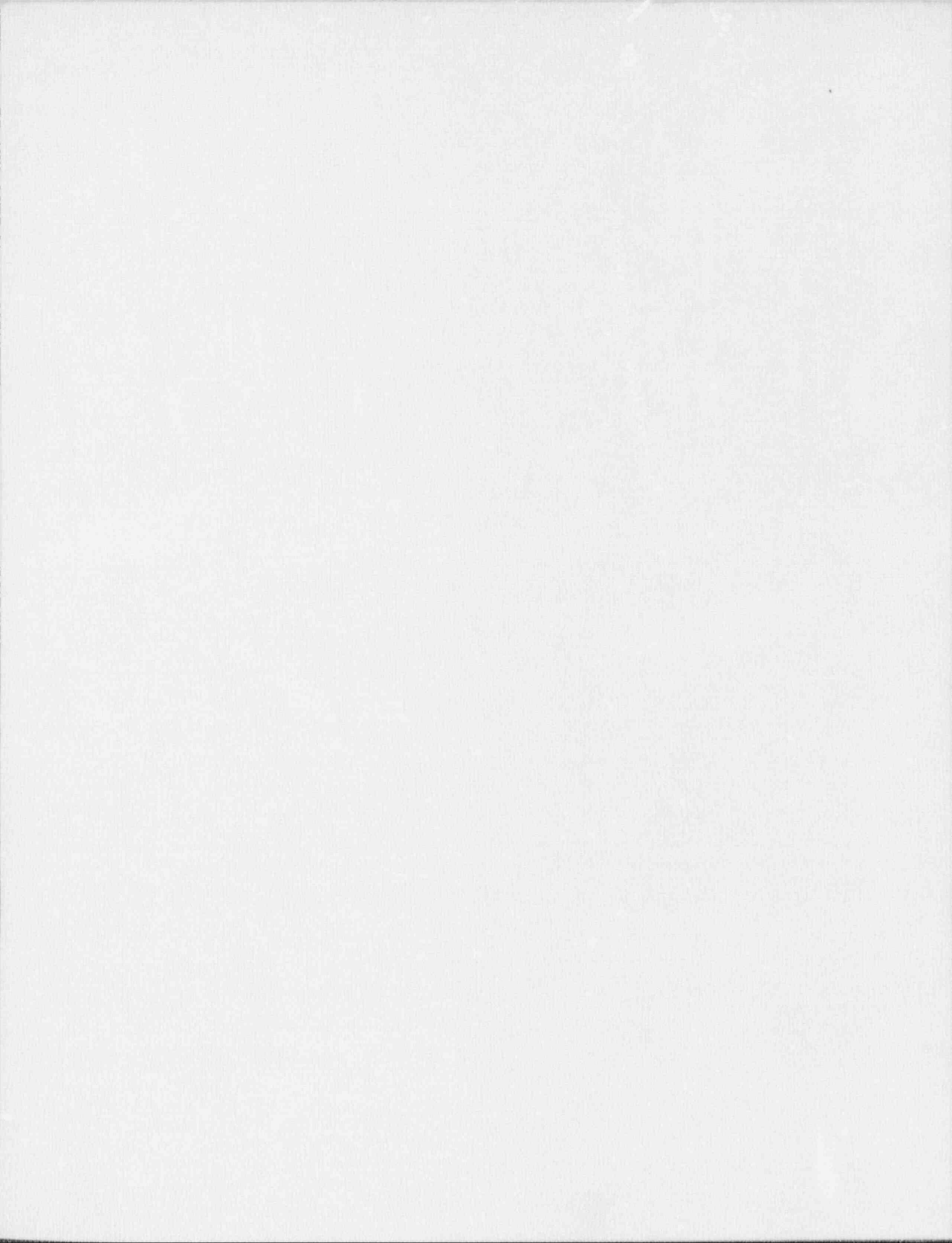
