As required by 10CFR50.54(q), South Carolina Electric & Gas Company, acting for itself and as agent for South Carolina Public Service Authority, submits ten (10) copies of Revision 8 to the Radiation Emergency Plan.

Revision 8 reflects the recent update and approval of the Station Offsite Dose Calculation Manual (ODCM), in the refinement of the detection methods for emergency action levels on gaseous effluent releases. This revision which has been reviewed by the Plant Safety Review Committee (as required by Technical Specifications) does not decrease the effectiveness of the Radiation Emergency Plan to meet the standards of 10CFR.47(b) and Appendix E.
