Dear Mr. Long:

This is in further response to your letter dated July 13, 1982, in which you requested, pursuant to the Freedom of Information Act (FOIA), records referring or relating to steam generators and steam turbines.

By correspondence dated August 2 and August 10, 1982, we provided partial responses to your request, confirming the narrowing of the scope of your request and notifying you of pertinent records available for public inspection and copying at the NRC Public Document Room (PDR). While awaiting your visit to NRC's Office of Nuclear Reactor Regulation, the staff has been searching for and reviewing additional records subject to your request. At this time, we are providing another response, as noted below.

The eight records identified on enclosed Appendix C are being placed in the PDR. These records will be filed in folder FOIA-82-309 under your name.

The staff has also identified the following records which have already been made available at the PDR.


