IN RESPONSE REFER TO FOIA-82-309

Dear Mr. Long:

This is in further response to your letter dated July 13, 1982, in which you requested, pursuant to the Freedom of Information Act (FOIA), records referring or relating to steam generators and steam turbines.

By letters dated August 2, August 10, and September 10, we provided partial responses to your request. At this time, we are providing this further response.

The 15 records identified on enclosed Appendix D are being placed in the NRC Public Document Room (PDR) and will be filed in folder FOIA-82-309 under your name.

The staff informed us of two pertinent Commission meetings, held on December 4, 1981, and June 30, 1982, concerning steam generator tube experience. Records pertaining to these meetings are already available at the PDR for public inspection and are filed in folders for Commission meetings.

You may also wish to inspect at the PDR the correspondence filed in folders FOIA-82-210 and FOIA-82-A-6 regarding a draft NUREG report on the subject of unresolved safety issues regarding steam generator tube integrity. The staff expects to publish the report for public comment this fall. In the meantime, NRC has withheld this draft report from public disclosure. However, we made a list of references and relevant studies available for public inspection.

As you will recall, during a telephone conversation between you and Linda Robinson while you were inspecting records at the PDR on August 11, you inquired about a specific Westinghouse report referenced in a record that you located in the PDR. A copy of the nonproprietary portion of that report, which is identified at number one of Appendix D, is being placed in the PDR.

In regard to inspection of working files of five staff members, as noted in our letter dated August 10, this is to inform you that Mr. Keith Wichman has provided records subject to your request, which are identified at numbers 11, 13, 14, and 15 on Appendix D, and informed this office that he has no additional relevant records.

Ms. Robinson will telephone you next week to obtain clarification on several pending matters, such as your continuing interest in inspecting working files as noted above.
