AFFIDAVIT OF JESSIE DEERINWATER

I, Jessie Deerinwater, depose and say:

1) I am a member of Native Americans for a Clean Environment ("NACE"), and I authorize NACE to represent my interests in the license renewal proceeding for Sequoyah Fuels Corporation's uranium processing plant in Gore, Oklahoma.

2) My address is Route 2, Box 51B, Vian, Oklahoma, 74962. My home is approximately ten miles northeast of the SFC plant.

3) My family's only source of drinking water is a well on our property.

4) To travel to Muskogee, or other places west of my residence, I generally have to drive on Interstate 40, which passes within two miles of the SFC plant; or on State Highway 64, which passes within one mile of the plant. I travel on these roads past the SFC plant about one to three times each week.

5) I and my family eat deer and squirrel meat from animals that we hunt on our property. To my knowledge, these animals range freely over a large area that includes the SFC plant's grounds and surrounding environment.

6) I enjoy hiking in the outdoors, and in years past my family and I regularly visited the Sequoyah Wildlife Refuge, which lies about three miles southeast of the SFC plant. However, three or four years ago we stopped visiting the refuge when the federal government declared that it was contaminated with selenium, one of the heavy metals produced by the SFC plant.

7) I am very concerned about the numerous accidents, spills, explosions of hazardous materials, and incidents of soil and groundwater contamination that have occurred at the SFC plant over the years it has operated. I believe the SFC plant poses a

risk to the health and well being of myself and my family, and threatens our interest in a clean and healthy environment.


