This letter transmits the results of the routine resident safety inspection by Messrs. T. Kenny, L. Scholl, and Ms. M. Evans from October 16 - November 17, 1990, at the Limerick Generating Station, Limerick, Pennsylvania. The inspection consisted of document reviews, interviews, and observations of activities. The results have been discussed with Mr. Graham Leitch and Mr. Martin McCormick, Jr. of your staff.

During our inspection, a failure to follow the plant housekeeping procedure was identified during the reassembly of the Unit 1 reactor vessel following refueling. We noted that you have taken appropriate corrective actions in response to this violation. As a result, we have determined that this satisfies the criteria stated in 10 CFR 2, Appendix C, Section V.A, and as such, no Notice of Violation will be issued.
