Subject: Quality Assurance for Deferred TVA Plants

By letter dated May 24, 1982, we requested that you provide additional information regarding quality assurance measures being taken to prevent degradation of safety related items for plants under deferrment by TVA.

Your August 6, 1982 response, which we understand to be applicable to Hartsville Units A1, A2, B1, B2, Phipps Bend Units 1 and 2 and Yellow Creek Units 1 and 2 is acceptable based on the further clarification and understanding obtained by telephone on August 18, 1982.

In order to find your August 6, 1982 submittal acceptable, we needed to clarify whether the QA program modifications are at the PSAR/Topical Report level. That is, while we do not need to know about changes at the procedure/instruction level, we do need to know of any portions of PSAR Sections 17.1 or of Revision 5 to Topical Report TVA-Tk/5-1A, "Quality Assurance Program Description for Design, Construction, and Operation of TVA Nuclear Power Plants," which are modified for the deferred plants. During a telephone call of August 18, 1982 with J. Delzer, Construction QA Branch; W. Dibeler, Construction QA Branch Chief; S. Duhan, OEDC QA; D. Lambert, Licensing; R. Pedde, Assistant to Manager, Construction; and J. Ritts, Engineering/Design Licensing of TVA, we were assured that the QA program modifications for the deferred plants are at the procedure/instruction level and do not affect the PSAR topical report except for organization changes which reflect the reduced effort and will be reported separately. Thus, the information received from TVA (by letter of August 6, 1982 as clarified by telephone conversation of August 18, 1982) regarding QA for deferred plants is acceptable.
