This letter is being transmitted to document the actions being taken on the development of the GGNS Emergency Operating Procedures (EOP) in response to our previous letter of October 12, 1982 (AECM-82/472).

Mississippi Power & Light Company (MP&L) had committed to a formal submittal of the GGNS EOPs by October 29, 1982. On October 26, 1982, MP&L informally transmitted a draft copy of recently revised GGNS EOPs to your Mr. Jim Clifford (PTRB) for initial review. These EOPs were written in accordance with the formatting provided by the INPO EOP Writing Guideline and Rev. 2 of the BWROG Emergency Procedures Guidelines. Based on Mr. Clifford's review and our subsequent telephone communications with him on October 29, 1982, MP&L has elected to additionally revise the GGNS EOPs prior to formal transmittal to the NRC for review.

MP&L will provide the NRC with revised EOPs by November 12, 1982. These procedures will include additional inhouse review for clarity, and further consideration of the NRC procedure review comments provided in February 1981. A meeting between the NRC and MP&L has been tentatively set for November 16th and 17th at the GGNS site to resolve any remaining areas of concern. We request that Mr. Clifford be available to support this meeting in order that timely resolution of this concern can be accomplished for our full power operating license.

We anticipate that this issue will be resolved as a result of our formal submittal and the following meeting.
