

Memorandum

In ALAB-942, issued December 21, 1990, the Appeal Board reversed this Board's determination that it lacked jurisdiction over the issues raised by Massachusetts Attorney General Contention 56, Basis A. The matter is remanded for further proceedings. Slip op. at 43-44.
