Gentlemen:

This refers to the inspection conducted by James A. F. Kelly of this office during a period commencing more than a year ago and culminating with a visit to Louisiana Power and Light Company (LP&L) Corporate Headquarters between May 25-27, 1982. These preoperational activities, covered under Construction Permit Number CPPR-103, may lead to an NRC Operating License. This letter also refers to the discussion of our findings with members of your staff at the conclusion of the inspection.

The inspection related to your program and activities designed to protect against industrial sabotage and to safeguard special nuclear material. The inspection was based on the applicable provisions of Title 10, Part 50 of the Code of Federal Regulations entitled "Licensing and Utilization Facilities," within Part 73 entitled "Physical Protection of Plants and Materials," and the specific requirements which will be applicable under an NRC Operating License. Areas examined during the inspection and our findings are documented in the enclosed inspection report. Within these areas, the inspection consisted of a selective examination of procedures and representative records, interviews with appropriate officials and LP&L personnel, and observations by the inspector.

Within the scope of the inspection, no violations or deviations were identified.

The documentation of findings of your planned control and accounting procedures for safeguarding special nuclear materials and your facility's security procedures are exempt from disclosure. This exemption is covered within Title 10 CFR Part 73.21, entitled "Protection of Unclassified Safeguards Information." Therefore, the inspection report will not be placed in the Public Document Room and distribution will be limited.
