You assert the following as grounds for your request: 1. The continued failure of Borg-Warner check valves at Comanche Peak Steam Electric Station: 2. The failure of the Texas Utilities Electric Company to take adequate corrective actions to resolve these check valve failures; and 3. The questionable safety of certain Borg-Warner check valves installed at Comanche Peak.

Your Petition has been referred to the staff for action pursuant to Section 2.206 of Title 10 of the Code of Federal Regulations (10 CFR). As provided by 10 CFR 2.206, the U.S. Nuclear Regulatory Commission will take appropriate action on your request within a reasonable time.
