The purpose of this modification is to provide CY 1991 funds in the amount of \$16,100.00 for TLD monitoring programs at Braidwood Nuclear Power Plant, Byron Nuclear Power Plant, Clinton Nuclear Power Plant, Dresden Nuclear Power Plant, LaSalle Nuclear Power Plant, Quad Cities Nuclear Power Plant, and Zion Nuclear Power Plant. Accordingly, the following change is made:

1. Article V - CONSIDERATION AND PAYMENT, Paragraph A., Consideration, Paragraph 3., is revised to read as follows:

"3. The amount presently obligated by the Commission with respect to this Cooperative Agreement since inception is \$78,050.00."

All other terms and conditions of this Cooperative Agreement remain unchanged.
