Enclosed are five (5) copies of responses to questions on WCAP-10924-P, Volume 1, Addendum 4; "Westinghouse Large Break LOCA Best Estimate Methodology: Model Description and Validation," Addendum 4, "Model Revisions" [Proprietary]. The questions were issued in a Request for Additional Information by Mr. Robert C. Jones, Chief, Reactor Systems Branch, in his letter dated November 6, 1990.
