On September 20, 1989, the NRC Staff issued Generic Letter 89-19.⁽¹⁾ In responding to the Generic Letter,⁽²⁾ Connecticut Yankee Atomic Power Company (CYAPCO) and Northeast Nuclear Energy Company (NNECO) committed to submit license amendment requests which would add provisions to the technical specifications to periodically verify operability of the overfill protection system.

CYAPCO and NNECO had expected that these license amendment requests would be submitted for Staff review by December 31, 1990. However, we have reestablished the date for submittal as February 28, 1991, to allow sufficient time for the internal review process.


