This letter confirms verbal authorization provided to Lou Albers on December 7, 1990, by Brenda DuBose, of my staff, to commence work on the subject task order modification effective December 7, 1990, with a temporary ceiling of \$1,000.00.

Therefore, in accordance with the task procedures of the subject contract, this letter definitizes Modification No. 1 to Task Order No. 9. This effort shall be performed in accordance with the enclosed Statement of Work and the Contractor's proposal dated December 6, 1990, incorporated herein by reference.

The cost ceiling of this task order is increased by \$1,317.00 from \$22,681.21 to \$23,998.21. Of the total cost ceiling amount, the amount representing the total reimbursable costs is increased by \$1,317.00 from \$22,114.48 to \$23,431.48. The facilities capital cost of money and the fixed fee remain unchanged.




