RESCISSION OF LICENSE AMENDMENT

I

Boone Hospital Center (Licensee) is the holder of Byproduct Material License No. 24-01565-02 (License), issued by the Nuclear Regulatory Commission (NRC or Commission) pursuant to 10 C.F.R. Part 30. The License authorizes the Licensee to use and possess byproduct material in accordance with the terms and conditions specified therein. The Commission originally issued the License on November 3, 1959 and issued Amendment No. 27 on September 10, 1990. The License is due to expire on March 31, 1991.

II

Pursuant to 10 C.F.R. §30.35 (the decommissioning rule), the Licensee sent a letter dated July 25, 1990 to the NRC in which the Licensee made commitments to satisfy the decommissioning rule. In accordance with the NRC staff's routine practice of incorporating licensee commitments into their licenses, the NRC staff issued Amendment No. 27. Amendment No. 27 incorporated the Licensee's commitments into the License by reference, referring to the commitments made in the Licensee's letter of July 25, 1990, and giving the dates of that letter.



Amendment No. 27, however, incorporates into the License requirements that are already required by the decommissioning rule, and therefore, that amendment is redundant and unnecessary. In view of the above, the NRC has determined to rescind Amendment No. 27 to the License.

IV

Accordingly, Amendment No. 27 to the License is hereby RESCINDED, EFFECTIVE IMMEDIATELY, and the License in effect for the Licensee is that license in effect without issuance of Amendment No. 27.
