Gentlemen:

This refers to the inspection conducted by Messrs. R. T. Redano, W. S. Schum, and M. E. Murphy of our staff during the period September 16-17, 1982, of activities authorized by NRC Operating License R-88, and to the discussion of our findings with you and other members of your staff at the conclusion of the inspection.

In addition to the routine inspection of your licensed activities, this inspection served to introduce R. T. Redano as principal inspector for your facility effective September 13, 1982.

Principal areas examined during the inspection included: (1) organization, logs, and records; (2) review and audit function; (3) requalification training; (4) procedures; (5) surveillance activities; (6) experiments; (7) radiation control practices; (8) environmental protection; (9) emergency planning; and (10) followup on unresolved items. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors.

Within the scope of the inspection, no violations or deviations were identified.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC's Public Document Room.
