Subject: Inspection Report Nos. 50-334/90-27 and 50-412/90-27


A routine, unannounced safety inspection of your emergency preparedness program was conducted by Mr. E. Fox of this office on November 27-30, 1990 at your Beaver Valley Nuclear Power Station, Units 1 & 2, Shippingport, Pennsylvania. Discussions of our findings were held by Mr. Fox with members of your staff at the conclusion of the inspection.


