Gentlemen:

This refers to the Emergency Preparedness Appraisal Followup conducted by C. A. Hackney and other NRC staff members during the period July 19-23, 1982, of activities authorized by NRC Operating Licenses DRP-51 and NPF-6, and to the discussion of the Appendix A and Appendix B items with J. M. Levine, and other members of your staff, at the conclusion of the Emergency Preparedness Appraisal Followup.

Areas examined during the followup are documented in the enclosed report. Within these areas, the followup consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the auditors.

Within the scope of the followup, no violations or deviations were identified.

We have also examined actions you have taken with regard to previously identified items. The status of these items is identified in paragraph 2 of the enclosed report.

We recognize that an explicit regulatory requirement pertaining to each item identified in Appendix B may not currently exist. Notwithstanding this, you are requested to submit a written statement within 60 days of the date of this letter of the results of your consideration of each of the items. This description is to include: (1) steps which have been taken; (2) steps which will be taken; and (3) a schedule for completion of actions for each item. This request is made pursuant to Section 50.54(f) of Part 50, Title 10, Code of Federal Regulations.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room, unless you notify this office, by telephone, within 10 days of the date of this letter, and submit written application to withhold information contained therein within 30 days of the
